### About the National Seminar

A respectable education is a distant dream for the children of a brothel. Fear of pimps and traffickers, teach children to argue and question everything and prevents the majority of these children, particularly females, from receiving an education. Even though they enroll in school in small numbers, they frequently drop out since exposure to the outside world forces them to confront the harsh reality that they are "socially unacceptable." Most of these children fall into the category of "marginalized" or "disadvantaged". In light of Article 15(3), it is necessary to mainstream these children in order to protect their childhoods and prevent child prostitution. While the State is authorized to do this under this Article, nothing has been done thus far. Under this backdrop under its mandate, National Commission For Women (NCW) has entrusted the Bharatiya Institute of Research and Development (BIRD), New Delhi to Organize а National Level Seminar/Conference at Ghaziabad on "the Legal, Health, and Educational Status of the Children of Commercial Sex Workers in India in order to identify the Problems, Difficulties, and Opportunities associated with mainstreaming these children.

### **Objectives of Seminar**

• To understand the current educational status of children of sex workers between the age group of 5-18:

• To examine the Constitutional Provisions and Laws Governing the Rights of Children of Sex Workers, their implementation and assess the impact of Right to Education (RTE) on the Children of Sex Workers;

• To identify the factors affecting the education of children of sex workers and to examine the attitude of children of female sex workers towards education and their career aspirations.

To assess psychological wellbeing and status of Safety & security of the children of Commercial Sex Workers;

• To explore the educational challenges & needs (Social needs, General needs, Health Needs & Psychological Needs) of children of sex workers while assessing the formal education and the availability of types of services to overcome these challenges and fulfil their needs.

• To understand the support systems and Services available to children of sex workers for education and knowledge/awareness about existing Government schemes such as National Crèche Scheme, ICDS & ICPS to support the children of sex workers.

• To create a roadmap for rehabilitation and mainstreaming of children of sex workers.

### **Sub Themes**

- Legal Status of female sex workers' (FSWs) under the Indian legal framework, their conditions of rendering service, rights, and remedies available, psychological wellbeing of children of sex workers
- Familial environment in which the children of sex workers are raised in,
- Level of self-esteem and self-efficacy of children of FSWs
- Socio, economic and cultural background of the women in sex work
- Health seeking behaviour of sex workers with reference to Sexual and Reproductive Health

- The Paper should be in .doc/.docx formats in Times New Roman, font size 12 with 1.5 line spacing. All participants must submit a presentation by using MS PowerPoint.
- Footnotes should be in Times New Roman, the font size 10 with 1.0 line spacing. Endnotes are not allowed.
- Alignment -Justified, no page borders, Margin 1 inch on each side.
- The writings must conform to the "Bluebook 20th Edition".
- All submissions should be original and nonplagiarized work, and should not have been submitted for publication/published elsewhere in any form.
- Similarity should not be more than 10%.
