About the National Seminar

As per the data for Periodic Labour Force Survey1 (PLFS) for the year 2021-22, Women account for 32% of the workforce in the informal economy, including agriculture and 20% of the non-agricultural workforce. 118 million women workers are engaged in the unorganized sector in India, constituting 97% of the total women workers in India. The informal sector in the non-agriculture segment alone engaged 27 million women workers in India. Work participation rate is found to be higher among rural women (27%) than the urban women (10%). The women in unorganized sector are overworked, their work is Invisible, Unrecognized and Unremunerated. It is characterized by the presence of factors viz. long hours of work, wage discrimination of men and women, lack of job security, no minimum wages, lack of minimum facilities at work place, ill-treatment, heavy physical work and sexual exploitation etc. Under this back drop under its mandate, National Commission For Women (NCW) has entrusted the Bharatiya Institute of Research and Development (BIRD), Delhi to Organize а National Level New Seminar/Conference at Ghaziabad on "Working Women in Unorganized Sector in India: Issues & Challenges in order to identify the Problems, issues, and challenges associated with women working in informal economy in India.

Objectives of Seminar

- To evaluate the existing policy and legislative frameworks which regulate the unorganised sector and analyse their impacts on female workers;
- To ascertain the situation of women employed in unorganised sectors in India and the societal prejudices and stigmatisation they encounter;
- To analyse the specific challenges, obstacles, susceptibilities, and problems encountered by women working in India's diverse informal economy;
- To examine the health issues encountered by women in the informal sector, including difficulties in accessing healthcare services, occupational risks, reproductive health concerns, and incidents of sexual violence (including harassment).
- To understand unorganised sector employment conditions, wages, and gender discrimination.
- To put forward legislative changes, such as labour laws, social security programmes, and affirmative action policies, to increase the rights and safeguards of unorganised sector women.

Sub-Themes

- Changing pattern of Indian working women in the unorganized sector.
- The socio-economic condition of Indian women in the unorganized sector.
- Social security of Indian women working in the unorganized sector.
- Differences in-service conditions of Indian working women of the organized sector and unorganized sector such as pay disparities, working environment etc.
- Contribution of Indian working women in different unorganized sector such as agriculture, manufacturing, services etc.
- Health, safety, and well-being of Indian women working in the unorganized sector.
- Labor laws of central and state government for the working women in the unorganized sector.

The National Commission for Women was set up as statutory body in January 1992 under the National Commission for Women Act, 1990 (Act No.20 of 1990 of Govt. of India) to review the Constitutional and Legal safeguards for women; Recommend remedial legislative measures; Facilitate redressal of grievances and Advise the Government on all policy matters affecting women.

It organized workshops/consultations, constituted expert committees on economic empowerment of women, conducted workshops/seminars for gender awareness and took up publicity campaign against female foeticide, violence against women etc. in order to generate awareness in the society against these social evils.

Call For Papers

Papers/Research Papers are invited from academicians, regulators, policy makers, research scholars, NGOs, students and other stakeholders across the streams.

Guidelines For Submission of Papers:

- Co-authorship is permissible. Each author will register them separately.
- The abstract should not exceed 300 words. The maximum word limit of the paper must not exceed 6000 words inclusive of footnotes.
- The paper must include the title of the paper, full name(s) of the Author(s), Affiliating Institution, Professional/ Educational Details, Email address and contact details.
- The Paper should be in .doc/.docx formats in Times New Roman, font size 12 with 1.5 line spacing. All participants must submit a presentation by using MS Power Point.
- Footnotes should be in Times New Roman, the font size10 with 1.0 lines pacing. End notes are not allowed. Alignment -Justified, no page borders, Margin 1 inch on each side.
- The writings must conform to the "Blue book 20th Edition".
- All submissions should be original and nonplagiarized work, and should not have been submitted for publication/published elsewhere in any form. Similarity should not be more than10%.
